



# 14-18 Forester Dual Ditch Light Mount

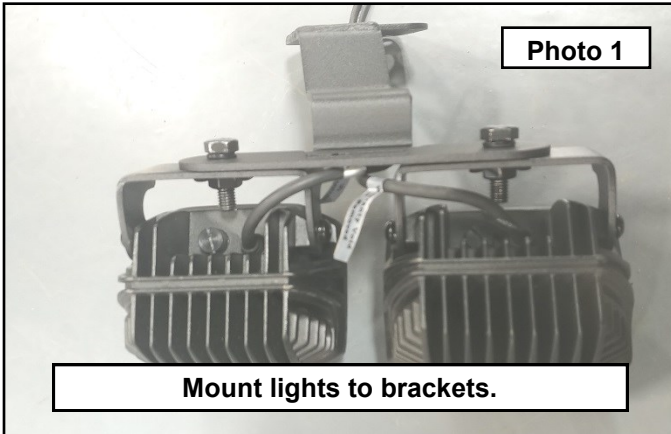

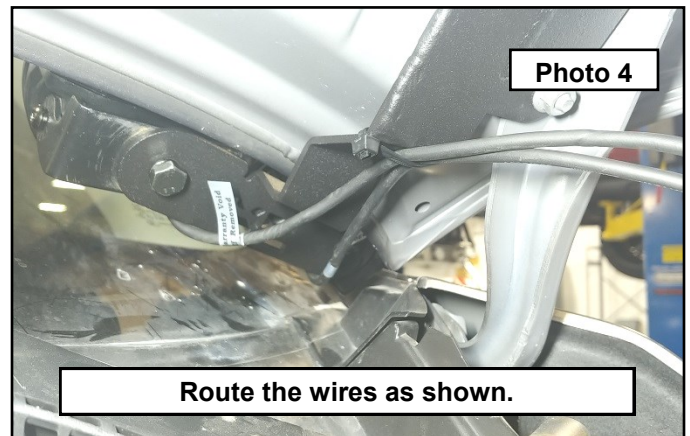
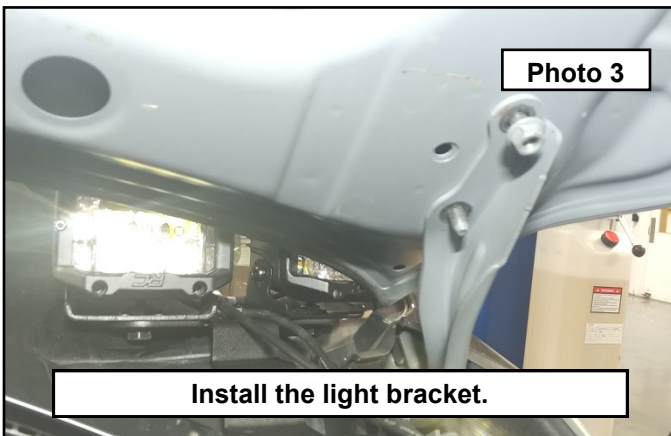


### Ditch Light Mount Installation

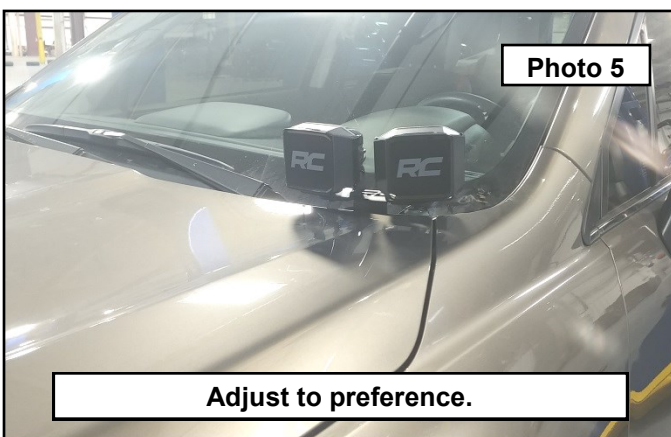
1. Mount the lights to the brackets using the provided hardware from the light kit. Make sure to run the mounting bolts facing up as shown otherwise the bolt could make contact with the wiper blades. Do not fully tighten at this time. Route the wire as shown. **Photo 1**
2. Open the hood and locate the hood hinge mounts. **Photo 2**



3. Slide the assembled light bracket between the hood and windshield. Working on one side at a time, remove the hood hardware using a 12mm socket. **Photo 3**
4. Install the bracket using the factory hardware. Torque to 10 ft-lbs. Route the wires along the bracket and zip tie in place as shown. **Photo 4**



5. Wire the lights accordingly. Close the hood and adjust the lights to preference. **Photo 5**
6. Check with local laws concerning coverings. If you are not sure, it is suggested to run the black out covers to avoid any infractions while on the street. Activate the wiper blades and make sure there is not any contact. Adjust as necessary. **Photo 6**
